The Company warrants this Leaf Net to be free of defects in workmanship. Examine your Leaf Net carefully before installing. Handle your Leaf Net carefully during inspection and installation as the Manufacturer is not responsible for tears or punctures caused by improper handling.

Leaf Net pool covers are warranted free of defects for a period of four years from date of purchase on a pro-rated basis, based on the Manufacturer's suggested retail price. Replacement under this Limited Warranty is as follows:

**To File A Claim:** Please contact our Customer Service Department at 1-800-356-3025 to speak with a representative. Have your customer number and sales order number available for verification purposes. Photos of the Leaf Net Cover damage/defect will be required for review. If the Leaf Net Cover is deemed to be covered under warranty you may be asked to send a 12-inch by 12-inch section of the damaged/defective area to the address in the top right hand corner of this Warranty sheet. Include a copy of your sales order receipt with the submitted sample. Collect shipments will be refused.

**IMPORTANT NOTE:** Many above ground pools have sharp corners where segments of components join. Pad these sharp edges with any soft material such as burlap, foam rubber, etc., to avoid wear and cutting of the Leaf Net. Failure to do this voids this Warranty. This Warranty specifically does not cover damage to the Leaf Net Cover due to wear caused by sharp instruments or abrasion. Leaf Net Covers must also be removed before first snowfall and ice storms. Excessive abrasion and grommets pulling out are specifically excluded from this Warranty.

THE COMPANY DISCLAIMS ALL OTHER WARRANTIES AND CONDITIONS, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. REPLACEMENT OF DEFECTIVE PRODUCTS AS PROVIDED UNDER THIS WARRANTY IS YOUR EXCLUSIVE REMEDY.
